

# 2005 Commercial & Industrial Capitalization Rates

The Johnson County Appraiser's Office commissions a capitalization rate study every two years. Separate studies are prepared for commercial/industrial properties and hotels. The studies are prepared by an outside appraisal firm. The rates shown were developed without deductions, from the income stream, for replacement reserves, tenant improvements or leasing commissions. Had any of these items been allowed in the expenses, the capitalization rates would have been proportionately lower. The rates were extracted directly from sales transactions and checked against other development techniques and other sources for reasonableness. Following is a summary of the rates that were developed:

**Please Note:** In estimating an appropriate OAR for properties at the low or high of a classification, the actual range from the recommended mid-point could be from +/- 0.25% to 0.875%.
