Executive Summary

1. Introduction

In 2015, Johnson County and sixteen of the twenty cities in the county signed Cooperation Agreements allowing the county to continue its qualification as an "urban county", namely, a jurisdiction with a population over 200,000. This qualification entitles the county to receive annual Community Development Block Grant (CDBG) funds from the U.S. Department of Housing and Urban Development (HUD) for Federal Fiscal Years 2016-2018. The City of Lenexa decided to accept its entitlement status for the 2016 program year.

The "urban county" includes the county and the cities of De Soto, Edgerton, Fairway, Gardner, Lake Quivira, Leawood, Merriam, Mission, Mission Hills, Mission Woods, Olathe, Prairie Village, Roeland Park, Spring Hill, Westwood, and Westwood Hills. The cities of Lenexa, Overland Park and Shawnee are not part of the urban county, since they are entitlement cities and receive their own CDBG funds. The city of Bonner Springs is only partially in the county and its seat of government is in Wyandotte County.

In 1994 the County qualified as a "participating jurisdiction" entitled to receive a HOME Investment Partnerships (HOME) formula allocation. All of the urban county cities can participate in the HOME program. However, in order for the cities of Overland Park and Shawnee to participate in the HOME program, each city signed a Cooperation Agreement with the county, forming the Johnson County HOME Consortium, with the county as the lead agency. Lenexa has chosen not to join the HOME Consortium since becoming an entitlement city.

This 2017 Action Plan covers the period beginning January 1, 2017 through December 31, 2017. The proposed activities in the plan are intended to benefit low to moderate-income Johnson County residents. Lenexa, Overland Park and Shawnee will prepare their individual plans for their cities since they are entitlement areas.

3. Evaluation of past performance

The priority needs listed in the 2015-2019 Consolidated Plan included: Housing, Public Facilities, Homeless, and Public Services. During 2015, Johnson County completed year one of the five year consolidated plan. During the 2015, which covers January 1, 2015 through December 31, 2015, a total of \$1,290,514 in CDBG funds was disbursed in the following categories.

\$499,647 (39%) funded Public Facilities

\$438,848 (34%) funded Housing Rehabilitation Projects

\$182,320 (14%) funded Public Service Projects

\$169,699 (13%) funded Planning and Administration

HOME Investment Partnership Funds

During the 2015 Program Year, which covers January 1, 2015 through December 31, 2015, a total of \$1,243,399 in HOME funds was disbursed.

4. Summary of Citizen Participation Process and consultation process

Summary from citizen participation section of plan.

The primary purpose of the programs provided by the Citizen Participation Plan is to "improve communities by providing decent housing, a suitable living environment, and growing economic opportunities, principally for low and moderate-income people." It is necessary that public participation genuinely involve the beneficiaries of these funds. Therefore, the goal of the Citizen Participation Plan is to encourage the participation of low- and moderate-income persons, particularly those living in areas where the use of CDBG and HOME funds is being proposed, as well as the participation of all interested citizens, social service providers and public agencies. This plan is designed to provide every opportunity for citizen participation and to insure openness and the freedom of access to information through each stage in the CDBG and HOME process.

This Action Plan is a result of public outreach, public hearings, and input from agencies, groups, county agencies, and cities to access the needs of low to moderate-income clients and residents. These groups included organizations involved in the development of affordable housing, agencies that provide health services, local housing authorities, fair housing services, persons with disabilities, persons with HIV/AIDS, homeless persons, and representatives of low-income residents.

To broaden public participation in the development of the action plan and reach the entire community, public notices were placed on the front page of the Johnson County Community Development website, and information shared with the local Continuum of Care on Homelessness and executive board. Input and comments were requested from community providers and a draft of the report was placed at the Central Resource Library with the availability published in <u>The Olathe News</u>.

The Citizen Participation Plan was updated to reflect the updates for the Affirmatively Furthering Fair Housing (AFFH) report. Johnson County's report will be due in April 2019.

5. Summary of public comments

The following is a summary of comments that Johnson County received from the public, including entities interested in carrying out CDBG activities at the October 27, 2016 public hearing:

Annual Action Plan 2017

- 1. Safehome, Inc.-Janee Hanzlick-Addressed domestic violence numbers in Johnson County. The first speaker spoke about the rise of domestic violence in Johnson County, and how Safehome is the only domestic violence shelter located in the County, and the largest in the State of Kansas. She informed the Board that Safehome's 60-bed shelter is completely full and they have people sleeping on pull-out couches. They are seeing an unprecedented increase in clients who have severe mental health issues, severe physical issues, and very severe financial issues. Ms. Hanzlick urged county commissioners to continue making ending domestic violence a priority in Johnson County.
- 2. Friends of Johnson County Developmental Supports-Janel Bowers-Talked about homes for developmentally and intellectually disabled residents. Ms. Bowers spoke on how the grants have helped and enabled her organization to provide housing that is accessible, that is safe, and is affordable to developmentally and intellictually disabled adults. The population she works with is living longer and their program allows people to be able to age in place.
- 3. City of Olathe-Aaron Holister-Informed the Board about the Olathe Taxi Coupon Program.Mr. Holister spoke about the Olathe Taxi Coupon Program and how it is able to provide transportation services to their most vulnerable citizens. Olathe provided 40,735 one-way trips through September 2016 for medical, work, and personal destinations for 450 participants. Mr. Holister thanked the Board for allowing them to provide a high level of service to their lowincome citizens.
- 4. United Community Services-Valorie Carson-Addressed community poverty and homelessness in Johnson County and provided statistics to the Board.Ms. Carson informed the Board on the responsibilities of the Continuum of Care on Homelessness, and how the COC is charged with putting systems in place that prevent households from becoming homeless, and if that loss of housing is unavoidable, to quickly return them to permanenet housing and provide the wraparound services and supports they need to maintain housing successfully. She informed the group that UCS, as the COC lead agency, submits a competitive grant to HUD for resources to serve Johnson County residents. In 2015, over \$675,000 came through the COC grant. These funds, which leverage additional resources, support local service providers offering permanent and transitional housing and related supportive services to households.
- 5. Johnson County Parks and Recreation-Jennifer Anderson-Day camp scholarships provided to working parents.Ms. Anderson explained the before and after-school programs to Johnson County families, and the summer camps they provide. She explained these scholarships allow parents to work so parents are not worried about their children, and know they are safe and engaged in quality activities.

6. Summary of comments or views not accepted and the reasons for not accepting them

There were not any comments or views not accepted to date.

7. Summary

Johnson County Community Development will be the lead agency and, the cities in the Johnson Consortium, non-profits with a 501(c)(3), faith-based organizations, and Johnson County governmental departments will be the partner agencies for the 2017 Action Plan. We continue to increase the outreach of our program and make more citizens and agencies aware of the Community Development Block Grant Program.

This action plan is a result of public outreach, public hearings, and input from agencies, groups, county agencies, and cities to access the needs of low to moderate-income clients and residents. These groups included organizations involved in the development of affordable housing, agencies that provide health services, local housing authorities, fair housing services, persons with disabilities, persons with HIV/AIDS, homeless persons, mental health providers, and representatives of low-income residents. The directors of both the Johnson County Housing Authority and the City of Olathe Housing Authority were consulted in developing the Action Plan. The Johnson County Housing & Community Development Advisory Committee, appointed by the Johnson County Board of County Commissioners assisted in the development of the plan.

Describe coordination with the Continuum of Care and efforts to address the needs of homeless persons (particularly chronically homeless individuals and families, families with children, veterans, and unaccompanied youth) and persons at risk of homelessness.

In gathering information on the needs of the homeless, a number of agencies were involved. The Johnson County Continuum of Care for Homelessness was consulted on homeless needs and provided an analysis of gaps in the current homeless housing system. United Community Services provided input and responses to questions as the lead agency for the Johnson County Continuum of Care on Homelessness. The members identified and prioritized numerous housing and supportive service needs. Sub-committee meetings are held quarterly during the regularly scheduled COC meetings to focus on expanding housing options, employment, and data quality.

Describe consultation with the Continuum(s) of Care that serves the jurisdiction's area in determining how to allocate ESG funds, develop performance standards for and evaluate

outcomes of projects and activities assisted by ESG funds, and develop funding, policies and procedures for the operation and administration of HMIS

Continuum of Care meetings have focused on factors influencing risk for homelessness/returning to homelessness. The discussion includes common barriers to getting housed by the group. The common barriers by Continuum members included: credit barriers, transportation, evictions, documentation, and housing close to employment. Members reported that 97% of clients in permanent housing maintained or left for permanent housing instead of doubling up. In Johnson County, it was stated by members that a family needs to make \$36,000 per year to afford \$750 in rent. This information is used to identify gaps in services. The information obtained in meetings allowesJohnson County to develop performance standards, evaluate outcomes, and develop funding policies and procedures for the administration of HMIS should Johnson County receive Emergency Solutions Funding passed-through KHRC.

Johnson County Community Development held an Emergency Solutions Grant (ESG) meeting for organizations interested in applying for FY2016 funds on Monday, March 28, 2016. In the meeting it was discussed how to best focus funds and which organizations could play what roles in administering the grant. Valorie Carson from United Community Services, the Continuum lead agency, was there to assist in the process.

An application was submitted on behalf of Catholic Charities of Northeast Kansas, Hillcrest Transitional Housing, and Johnson County Mental Health. Johnson County was notified on July 18, 2016, that the group was awarded \$94,486 for federal fiscal year 2016.

1. Summary of citizen participation process/Efforts made to broaden citizen participation Summarize citizen participation process and how it impacted goal-setting

On April 30, 2016, a newspaper ad appeared in <u>The Olathe News</u> to inform the broad community of the needs assessment hearing for 2017 CDBG projects. Citizens were invited to attend the hearing or submit comments to the Community Development Coordinator. On April 15, 2016 a letter was sent out to the mayors of the Johnson County urban consortium notifying them of the Housing and Community Development Needs Assessment Public Hearing scheduled for May 16, 2016. Also on April 27, 2016, a notice was sent out to our community partners email distribution list with the date and time of the hearing. Throughout April 2016 the notice was placed on the front page of the Johnson County Community Development website. The needs assessment hearing was held May 16, 2016.

Outreach for the 2017 application workshop was expanded this year again at the request of County Commissioners. Community Development worked with the Public Information Office, a division of the County Manager's Office, to increase public awareness of the application process.

On September 17, 2016 a public notice was published in <u>The Olathe News</u> announcing that the public comment period would be opened by the Board of County Commissioners at the September 22nd session. The BOCC set September 23rd through October 26th as the public comment period and October 27th as the public hearing date for the proposed 2017 Action Plan. 5 citizens provided comments to the Board at the public hearing. The speakers included: Janee' Hanzlick of SAFEHOME, Janel Bowers of Friends of JCDS, Aaron Holister from the City of Olathe, Valorie Carson of United Community Services, and Jennifer Anderson of Johnson County Parks & Rec. Each speaker informed the Board of how they will utilize the recommended funding to benefit low to moderate-income residents during the 2017 program year and thanked them for their continued support of the CDBG program. There were no comments not accepted at the public hearing.

The HOME Rehabilitation Program is administered by Johnson County Housing Services. This program requires a 25% match. These funds are provided by participating cities in Johnson County, KS. Through a cooperative agreement between Builders Development Corporation (BDC) and Johnson County Housing Services, the private funds are used as in-kind match from the acquisition of properties that were HOME funded projects.

The City of Olathe leverages a variety of resources. They vary from soft cost covered by general funds, volunteer hours directed toward Habitat for Humanity/CHDO homes, waived taxes, general funded street, sewer, or water projects benefiting HOME projects, donations and other resources. Olathe continues to explore ways to match federal funds on home improvement projects.

The rating team receives a summary from the needs assessment hearing to factor in where there may be proposed gaps in services, and how those gaps could be addressed with CDBG activities. The applications are scored by the rating team who are members of the Johnson County Housing & Community Development Advisory Committee. A score sheet is completed by each member for each proposed activity. Scoring criteria include: need, the project, budget and timeliness, and performance measures.

The largest obstacle to addressing underserved needs is adequate funding from HUD to fully fund proposed projects on an annual basis.

Johnson County does not target a specific geographic area or areas of minority concentration for special funding. CDBG funds for general neighborhood improvements are limited to census block groups in which 33.92% or more of the residents are low- to moderate-income. HOME funded housing rehabilitation usually involves the oldest housing stock, which also tend to be located in areas most in need of infrastructure improvement. Public services receiving CDBG assistance are open to income eligible residents throughout the county, other than in the Cities of Lenexa, Overland Park and Shawnee which have their own CDBG funding. The City of Olathe has identified the Community Development Block Grant areas for some projects based on a 33.92% or greater number of low to moderate income families determined by the United States Census Bureau. Projects that are family specific requires the family to meet the income qualification for low to moderate income and can receive assistance if they live outside the CDBG designated area.

Discussion

The Johnson County Housing Authority's greatest need is to continue to fund the 1,447 Housing Choice Vouchers allocated. The Authority always needs additional funding to assist those families on the waiting list. There are currently 437 families on the waiting list.

The Housing Authority has an annual budget of \$9.2 million dollars to provide rental subsidy for extremely low to low-income families. Seventy five percent of all new admissions to the Housing Choice Voucher Program must be at the extremely low-income guidelines. Currently there are 1510 families under lease. This figure includes 74 vouchers holders from other Housing Authorities across the nation. Twenty five (25) Housing Choice Vouchers are earmarked for and used for the mainstream participants (persons with severe disabilities). Our Family Self Sufficiency Program, which helps families or individuals become independent of cash public assistance, currently has 33 families under contract, with the ability to contract up to thirty five (35).

Introduction

Actions planned during the next year to address the needs to public housing

Every five years Olathe Housing Authority prepares a five-year plan outlining organizational goals and proposed capital improvement projects.

Annually, Olathe Housing Authority will submit a scaled down version of the five year plan discussing their organizational, operational and capital improvement goals for the upcoming year. These may involve proposed, new, updated, or eliminated services. The annual capital improvements goals are submitted annually but not as a part of the Annual Plan.

During the next year, Olathe Housing Authority will be implementing federal rules and regulations; updating the Administrative Plan and the Admissions and Continue Occupancy Handbook; exploring the potential of setting aside Housing Choice Vouchers for homeless families; conducting an energy audit; implementing a No Smoking Policy in Scattered Site Housing; taking on the management of eight rental properties in Olathe; assessing the need for affordable housing; participate in emergency management plan; updating website and other issues or opportunities that may come about during the year.

Actions to encourage public housing residents to become more involved in management and participate in homeownership

Management - Olathe Housing Authority has an active Tenant Council that meets throughout the year and represents the voice of the tenants. They provide recommendations for policy and procedural changes as well as capital improvement. Prior to Olathe Housing Authority's Annual Meeting the Tenant Council will provide their recommendations so they can be incorporated into the literature handed out at meeting.

Monthly, the Executive Director or designee will meet with the tenants of Parkview Manor, low-rise with 64 one bedroom units and 2 two bedroom units to discuss issues and concerns that impact their community.

As a component within the City of Olathe, the city has an interactive program called "Olathe Connect" which allows citizens to direct comments, concerns, or questions to the appropriate program within the city. Olathe Housing Authority is a part of that program and is another avenue for tenants to be involved in the management of housing.

Homeownership – Olathe Housing Authority does not have a public housing homeownership program however tenants wanting to become homeowners are encouraged to attend the monthly Family Self-Sufficiency meetings. Staff will refer tenant to other organizations.

Describe the jurisdictions one-year goals and actions for reducing and ending homelessness including

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

Johnson County, Overland Park, and Shawnee in the 2017 action plans fund multiple public service agencies that serve homeless individuals and access their individual needs. During 2017, Johnson County has recommended funding for Catholic Charities of Northeast Kansas for emergency assistance, Johnson County Interfaith Hospitality to provide case management services to homeless families, Salvation Army for an emergency assistance program, and United Community Services for staff support and coordination for the Johnson County Continuum of Care on Homelessness. Overland Park has also included funding for Catholic Charities, Salvation Army, Johnson County Interfaith Hospitality, and also Hillcrest Transitional Housing. Shawnee has funded Catholic Charities and Salvation Army.

All of these programs listed above work with the homeless population in Johnson County to provide assistance to homeless persons.

Addressing the emergency shelter and transitional housing needs of homeless persons

Organizations within the county continue expanding and strengthening housing options for all households experiencing homelessness, given current options are primarily for households with dependent children and are often not available for immediate housing. Immediate shelter is often arranged by diversion or through a system of one night hotel vouchers until shelter beds are available or the household is accepted into a rapid re-housing program. Local organizations have worked to address a gap in emergency shelter for adult only households by one longstanding emergency shelter opening its doors to single female adults, when formerly it served only households with children and a cold weather shelter for homeless individuals opening when temperatures fall below 20 degrees Fahrenheit. Improved coordination between In addition, the majority of TH beds within the county have been converted to RRH beds and additional RRH beds have been created through Emergency Solutions Grant dollars in order to be more responsive to a range of need for assistance and support among households experiencing homelessness. We continue to take steps in conjunction with adjoining counties to build a unified system that brings together prevention, diversion, and emergency and permanent housing resources, incorporates service prioritization and offers individualized supports to stabilize homeless households.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

Several different strategies, with the framework of Opening Doors, are being implemented to improve outcomes for those who experience homelessness and will be ongoing. This includes, but is not limited to, further outreach into the schools and local law enforcement to identify at risk households, shifting from transitional housing programs to rapidly re-housing households and providing flexible services and supports in partnership with the client to reduce time experiencing homelessness and likelihood of returning to homelessness, building relationships between organizations serving the homeless and local landlords to improve housing opportunities and stability, further expanding a bridge to subsidized housing for those experiencing homelessness who will likely need ongoing housing assistance as indicated by a service prioritization tool, and providing case management services past short term rental assistance in order to build the capacity of households to weather future crises and prevent a series of events that could result in households losing their housing. In 2016, the local Continuum of Care on Homelessness began assessing its effectiveness as a system, and will use system level performance measures going forward to gauge its progress towards reducing lengths of time households experience homelessness, reducing returns to homelessness, and building households' income capacity in order to stably meet basic needs. This is complemented by the regional work to build a unified system that brings together prevention, diversion, and emergency and permanent housing resources and offers individualized supports to stabilize homeless households.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); or, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs.

For 2017, Johnson County has recommended CDBG funds be utilized to assist low-income and homeless individuals by funding various public services. Specific activities include:

• Catholic Charities of Northeast Kansas-Emergency assistance and financial literacy classes or coaching provided to income qualified residents to avoid homelessness, Johnson County Interfaith Hospitality Network-Funding for case management for homeless families and single unaccompanied female guests. Johnson County Parks and Recreation-Day camp scholarhips that allow working parents to have supervised care, Olathe Media Access-The project enables the City of Olathe's media outlet to effectively communicate city government news and information to the deaf and hard of hearing residents of Olathe through the Olathe Government Network. Olathe Taxi Coupon Program-Provides funding for low income, elderly, and disabled citizens to purchase coupons for transportation at a reduced cost to allow individuals to work. Salvation Army-Funding provided for emergency assistance to Johnson County residents to encourage stability and help prevent homelessness with rent and utility assistance. United Community Services-Staff support and project coordination for the Continuum of Care on Homelessness to improve response to poverty and reducing homelessness. YMCA of Greater Kansas City-Allows YMCA to offer low income families scholarships for before and after school care to allow parents to work.

For 2017, Overland Park has recommended CDBG funds be utilized to assist low-income and homeless individuals by funding various public services. Specific activities include:

- Catholic Charities of Northeast Kansas and Salvation Army-Emergency aid.
- Johnson County Parks and Recreation-Child care.
- Hillcrest Transitional Housing-Utility and rental assistance.
- Interfaith Hospitality Network-Homeless services.
- Community Living Opportunities-Remote coach program.

For 2017, Shawnee recommended CDBG funds be utilized to assist low-income and homeless individuals by funding various public services. Specific activities include:

- Catholic Charities of Northeast Kansas and Salvation Army-Subsistence payments.
- Johnson County Parks & Recreation and YMCA of Greater Kansas City-Child care services.

AP-75 Barriers to affordable housing -91.420, 91.220(j)

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

There has been an interest in providing Accessory Dwelling Units for aging parents, older or grown children, and family members with disabilities. The Johnson County Board of Commissioners approved and adopted Resolution 009-13, thereby approving certain amendments to the County's Zoning and Subdivision Regulations to allow Accessory Dwelling Units in the rural and residential zoning districts, as set forth within the resolution.

Johnson County began to develop a more efficient means for delivery of resources community wide, not just county government resources. The system was built in-house with staff from multiple county departments including: Automated Mapping Information Systems (AIMS), Department of Technology and Information (DTI), Mental Health, Developmental Supports, Corrections, Courts, Health and Environment, Human Services, and District Court Trustees.

The role of "My Resource Connection" is to assist individuals find and locate relevant resources at organizations. Individuals or case managers are able to perform searches for affordable rental housing, food pantries, transportation, health and medicine, counseling, employment, as well as many others, and contains mapping capabilities.

My Resource Connection is maintained and hosted by the government of Johnson County, KS. Significant contributions of data come from United Way 211 of Greater Kansas City, various departments within Johnson County government, and the Unified Government of Wyandotte County and Kansas City, KS. AP-85 Other Actions - 91.420, 91.220(k)

Introduction

It is the policy of Johnson County to provide fair and equal treatment to all persons in the access to and administration of government services. Johnson County Government does not discriminate against any qualified or eligible person in the provision of its services, the administration of its programs, nor in participation in its activities on the basis of race, color, sex, religion, creed, national origin, age, handicap, political affiliation or belief.

Actions planned to address obstacles to meeting underserved needs

In 2017, Johnson County proposes funding for the following underserved needs: Safehome, Shelter Improvements, (domestic violence); United Community Services, Homeless Coordinator, (homelessness); Johnson County Interfaith Hospitality Network, case management (homelessness); Friends of JCDS, housing rehabilitation (disabled); Olathe Media, media captioning (deaf community); and Olathe Taxi, transportation vouchers (elderly and disabled).

Actions planned to foster and maintain affordable housing

Improve the quality of existing housing through rehabilitation and increase the supply of housing affordable to low-income households. Support programs that provide rehabilitation of low-income renter and owner-occupied housing and/or provide emergency repair/replacement to address health, safety or accessibility issues. Support rehabilitation/purchase and/or new construction of housing units to be made available to low-income renters or buyers.

Actions planned to reduce lead-based paint hazards

On September 15, 1999, HUD published the "Lead Safe Housing Rule." The lead hazard reduction requirements in this regulation apply to housing built before 1978; the year lead-based paint was banned nationwide for consumer use. According to the U.S. Census Bureau, 53 percent of the county's housing stock was built prior to 1979.

In responding to HUD's Lead Safe Housing Regulation, Johnson County Housing Services has had two staff trained in Lead Safe Work Practices as Risk Assessors. As of August 2016, three (3) general contractors are certified Lead Activity Firms and eighteen (18) general contractors are certified as Lead Renovation Firms. To further augment the county's effort, the county contracts with Hernly and Associates to provide Lead-Based Paint inspection, risk assessment and clearance services. Hernly and Associates is certified to conduct Lead-Based Paint risk assessments by the Kansas Department of Health and Environment.

The City of Olathe takes steps to ensure all homes built before 1978 and receiving rehabilitation assistance (CDBG, HOME) are inspected by a certified risk assessor. When a home has identifiable lead hazards, the homeowner is informed of the additional steps that will need to be taken on their property prior to rehabilitation starting. This information includes the notification, evaluation and corrective steps needed to address the lead based paint hazards in their home. The City has contracted with a certified risk assessor to provide a full risk assessment on all rehabilitation projects over \$5,000, which include a visual inspection, paint testing (samples and XRF), soil samples and dust wipes.

A lead hazard risk assessment and lead-based paint inspection report is presented. This information is forwarded to the homeowner and the licensed contractor that will be performing the work.

If the testing reveals lead in or around the home the homeowner could receive a grant to address the lead issues. Depending on the cost to address the lead some expenses may be incorporated into a deferred loan. Once the hazard reduction work is completed, a clearance examination is performed with subsequent reports.

Both Johnson County Housing Services and the City of Olathe have always provided residents with the **Protect Your Family From Lead In Your Home** brochure (English or Spanish version) and these brochures are also made available at the county's Community Outreach Centers.

Actions planned to reduce the number of poverty-level families

Over the past three decades, the poverty rate in the county has remained fairly level with 3.6 % in 1980, 3.6% in 1990 and 3.4% in 2000. But poverty in the county is increasing. In 2014 the poverty rate for Johnson County was 6.6%, a large increase over past decades. In 2013, an estimated 32,890 Johnson County residents were living below the federal poverty level. Source: U.S. Census Bureau, 2013 American Community Survey and United Community Services. In addressing poverty, the county operates programs and collaborates with many non-profit organizations. The county provides funding for a utility assistance program, which cities participate in through matching funds. The county provides Community Outreach Centers where residents have access to a variety of resources, including a Self-Reliance program. Through its CDBG program, the county has funded activities specifically designed to move people out of poverty, such as: Childcare so that people can gain an education or remain at work; Self-sufficiency programs that move people toward financial goals; Homebuyer and housing programs. The county's anti-poverty strategy will be focused on raising the incomes of persons at or below

poverty. While continuing to support programs that help families continue an education, find and keep jobs or build skills, the county will place an emphasis on programs that help build wealth, especially the earned income tax credit program and individual development accounts.

Actions planned to develop institutional structure

Housing & Community Development Advisory Committee The Johnson County Housing & Community Development Advisory Committee is made up of eleven citizen members with a County Commissioner serving as non-voting chair. Four of the members are appointed as representatives of persons with disabilities, of minorities, of low-income households and of the homeless. According to a Board Resolution, the purpose of the Housing & Community Development Advisory Committee shall be to insure that the needs of extremely low- to moderate-income individuals and families, the elderly, disabled, minority and homeless populations are expressed and adequately reflected in Johnson County's housing and community development programs. The Community Development Block Grant (CDBG) is managed by the Community Development Office and the HOME Investment Partnerships (HOME) program, a weatherization program and home repair programs are managed by the Housing Services Office both within the Human Services Department. Other county departments or agencies involved in services to low-income households include the Area Agency on Aging, Developmental Supports, Mental Health, Parks & Recreation, and Public Health.

Actions planned to enhance coordination between public and private housing and social service agencies

The county has cooperation agreements for the CDBG program with the 16 of the 20 cities in the county. It also has cooperation agreements for the HOME program with the cities of Overland Park and Shawnee, both of which receive their own CDBG funds, but not HOME funds, as entitlement cities. Since only a small part of the City of Bonner Springs is within the county, that city does not participate in the county's programs. A city applies to the county for CDBG funding for activities approved by the city council after public hearings. As demonstrated in the yearly Action Plan, CDBG funds are provided to a number of supportive and social service providers. The county has numerous agencies, as well as faith communities, which provide a variety of services to diverse low-income populations.

Johnson County uses HOME funds in the forms of assistance as identified in the plan (i.e. grants, deferred loans). HOME INVESTMENT PARTNERSHIP PROGRAM

Resale/Recapture Provision

Johnson County Housing Services exercises the Recapture Provision for homebuyer activities undertaken under the **Homebuyer's Assistance Program**.

Homebuyer's Assistance Program is a deferred loan program. Eligible applicants are provided down payment and closing cost assistance up to \$10,000 to purchase a home. A lien is placed against the newly purchased home as a second mortgage. The loan, which is interest free, is forgiven at a rate of 20% per year (one year means 12 months from the closing date of the home) of the original loan amount for a five (5) year period. At the end of the five (5) year period the loan will be forgiven and the mortgage will be released.

If, at any time during the five (5) year affordability period, the property is sold to any willing buyer, or its title is otherwise transferred, the remaining amount of the deferred loan must be repaid to the HOME Program from available net proceeds prior to release of the mortgage.

Net proceeds are defined as the sales price minus superior loan repayment (other than HOME funds) and any closing costs.

Foreclosure, Transfer in Lieu of Foreclosure- If the property is foreclosed upon during the affordability period; JCHS will attempt to recoup any net proceeds that may be available through the foreclosure sale in an amount up to the HOME Program direct subsidy.

Non-compliance with the principal place of residency requirement by a homebuyer under the recapture provision is <u>not</u> considered a transfer and under these circumstances, JCHS will enforce full repayment of the HOME Program direct subsidy, which is not subject to prorated or other reductions included in the recapture provision described above. (See example below)

A homebuyer receives \$5,000 in Homebuyer's Assistance to purchase a home. The direct subsidy funded through the HOME Program is \$5,000.00. The recapture agreement provides for pro rata reduction of the direct subsidy over 5 years. If the homebuyer rents the property in year 3, he would be in noncompliance with the HOME principal residence requirement and would be required to repay the entire \$5,000.00 HOME Program direct subsidy.

3. A description of the guidelines for resale or recapture that ensures the affordability of units acquired with HOME funds? See 24 CFR 92.254(a)(4) are as follows:

Johnson County Housing Services (JCHS) exercises the Recapture Provision for homebuyer activities undertaken by Johnson County Housing Coalition (CHDO) and Builders Development Corporation (CHDO).

Johnson County Housing Services (JCHS) will exercise the recapture provision utilizing the model where in the JCHS, recaptures the entire direct HOME subsidy provided to the CHDO (Project Sponsor), if during the affordability period the property is transferred/sold to an entity other than the CHDO (Project Sponsor). If at the time of sale, there is a declining housing market, and net proceeds available at the time of sale are insufficient to recapture the entire direct HOME subsidy provided to the CHDO, only what is available from net proceeds will be recaptured.

Net proceeds are defined as the sales price minus superior loan repayment (other than HOME funds) and any closing costs.

HOME funds provided by the County shall be due and payable, and shall be returned to the County as Program Income. Any amounts in excess of the Direct HOME Subsidy disbursed to the CHDO (Project Sponsor) shall be retained by the CHDO Project Sponsor. Any agreement entered into by (CHDO) Project Sponsor providing for periodic reductions in the amount of the outstanding HOME funded balance during the affordability period shall not be binding upon any claim on sales proceeds or Program Income that may be made by the County.

The affordability period has previously been defined as the period after the Project is completed and final payments are made, in compliance with time limits dictated at 24 CFR 92.252(e), which term shall be not less than five years, nor more than twenty years, based upon total amount of HOME funds invested in the Project and type of project undertaken.

This model, *Recapture Entire Direct Home Subsidy*, shall be used for Acquisition as well as New Construction developed by the CHDO.

Foreclosure, Transfer in Lieu of Foreclosure- If a CHDO owned property is foreclosed upon or transferred in Lieu of Foreclosure during the affordability period, JCHS will attempt to recoup any net proceeds that may be available through the foreclosure sale in an amount up to the full amount of the HOME Program direct subsidy, and/or recapture from the CHDO for the full amount of the

HOME Program direct subsidy.
