The group broke out into the three different work groups with assignment of creating 1-2 SMART objectives.

Summary Notes from Physical Activity and Nutrition group

Objective – Create 1-2 SMART objectives. Although we arrived at a SMART objective toward the end, the bulk of our limited time together focused primarily on brainstorming ideas that could ultimately become objectives. Ideas generated from the brainstorming included:

- Complete Streets Program
 - Resolutions passed in Leawood, Roland Park and JOCO
 - Resolutions/initial work in progress in Olathe and Overland Park
- Create an event focusing on existing JOCO asset such as livable communities/neighborhood
 - Local food focus (farmer's markets, etc)
 - Ride/bike to event
- Use as awareness/kick off type of event possibly to tie-in with Complete Streets effort or other program launch
- Safe Routes to Schools
- Promote/develop Walking School Bus routes
- JOCO Library as host for community forum(s) on whatever objectives/projects we eventually choose

General thoughts about chosen project(s) and how to increase chances for effectiveness

- Focus on one community at a time rather than JOCO as a whole
- Environment/culture makes an impact on chosen project and how it is carried out
- Assess what is already working/not working before making final project decisions
- Assess business/general community support and assets before making final project decisions
- Tackle projects in small, manageable pieces
- Piggy back on existing assets/events such as Shawnee Days, Old Settlers, Lenexa Spinach Festival, etc.
- Focus on low/no cost projects when possible
- Consider sustainability and ability to replicate in other communities

Our Objectives:

1. Johnson County residents will increase their utilization of Johnson County’s mental health/substance abuse prevention and early intervention resources.
2. Johnson County residents will experience improved awareness and access to Johnson County’s mental health/substance abuse services and resources.

3. Johnson County mental health providers will report an increase in communication and collaboration between area agencies.

New Strategy Ideas:

- Jennifer Sykes with the Health Care Foundation (HCF) suggested that we interact with the Regional Healthcare Initiative process at MARC.
- HCF has funding available for mental health issues. We would need to send them a letter of intent by March to apply for these funds.
- Opportunity for continuing education classes at JCCC
- Marillac is open to sponsoring/supporting our efforts
- Regional Prevention Center has several MH/SA programs that are for youth and parents, such as “Guiding Good Choices” and “Strengthening Families”.
- Suggestion to make children and young adults 24 years of age and younger our target population
- Suggestion to make parents another target population

Questions that were raised:

- Do we want to focus on autism even if it is not technically a mental disorder? Several members at the table thought that we should. If so, how?
- Do we want to focus on bullying behavior?
- How do we want to focus on reducing the stigma of mental health disorders?
- How do we want to focus on practice and policy changes?
- What is our target group? Is it the same for every objective?
- Are our objectives measurable? How will we measure our success?
- How do we want to begin this process? Focus on one objective or one target population?
