#### **Essential Duties:**

- Participates in Epidemiologic assessments and analysis by recognizing public health and environmental problems
  pertinent to the population; participates in surveillance activities to identify acute and chronic conditions or other
  adverse outcomes in the population; organizes data from surveillance, investigations, or other sources; analyzes data
  from an epidemiologic investigation or study; summarizes results of the analysis and draw conclusions; assists in
  developing recommended evidence-based interventions and control measures in response to epidemiologic findings;
  and assists in the evaluation of programs.
- Prepares written and oral reports and presentations that recognizes the basic principles of risk to communicate necessary information to agency staff.
- Provides epidemiologic input into epidemiologic studies, public health and environmental programs, and community
  public health and environmental health planning processes at the state, local, or tribal level; and participates in
  development of community partnerships to support epidemiologic investigations.
- Establishes relationships with groups of special concern (e.g., disadvantaged or minority groups, groups subject to health disparities, historically underrepresented groups); describes surveillance systems to include groups subject to health disparities or other potentially underrepresented groups; conducts investigations using languages and approaches tailored to the population; and supports public health actions that are relevant to the affected community.
- Supports the organization's vision in all programs and activities; uses performance measures to evaluate and improve epidemiology program effectiveness to assist with promoting ethical conduct in epidemiologic practice; prepares for emergency response and foster collaborations, strong partnerships, and team-building to accomplish epidemiology program objectives.

#### **Minimum Job Requirements:**

Bachelor's degree in Biology, Epidemiology, Public Health, Nursing or related science and two (2) years' experience in epidemiology and communicable diseases in a public health or related setting are required. May require KS/MO driver's license, depending on department or agency.

Johnson County Government requires reference/background screening for all positions. Specified criteria may vary by Department/Agency.

#### **Preferred Job Requirements:**

Master's degree in A Master's degree in public health (MPH) or a master's of science degree in public health (MSPH) with a focus in epidemiology or analysis and assessment or other non-epidemiology graduate degree or certification (e.g., RN, RS) with specific epidemiology training (e.g., MPH degree, CDC Epidemic Intelligence Service or CSTE Applied Epidemiology Fellowship) and one (1) year of experience in communicable disease and/or environmental health focus in a public health or related setting are preferred.
