Essential Duties:

- Plans and conducts Epidemiologic assessments and analysis by identifying public health and environmental problems
 pertinent to the population; conducts surveillance activities to investigate acute and chronic conditions or other
 adverse outcomes in the population; manages data from surveillance, investigations, or other sources; analyzes data
 from an epidemiologic investigation or study; summarizes results of the analysis and draw conclusions; recommends
 evidence-based interventions and control measures in response to epidemiologic findings and evaluate programs.
- Prepares written and oral reports and presentations that demonstrate the basic principles of risk for communicating necessary information to professional audiences, policy makers, and the general public.
- Provides epidemiologic input into epidemiologic studies, public health and environmental programs, and community public health and environmental health planning processes at the state, local, or tribal level; and participates in development of community partnerships to support epidemiologic investigations.
- Establishes relationships with groups of special concern (e.g., disadvantaged or minority groups, groups subject to health disparities, historically underrepresented groups); designs surveillance systems to include groups subject to health disparities or other potentially underrepresented groups; conducts investigations using languages and approaches tailored to the population; and recommends public health actions that would be relevant to the affected community.
- Supports the epidemiologic perspective in the agency strategic planning process by promoting the organization's
 vision in all programs and activities; uses performance measures to evaluate and improve epidemiology program
 effectiveness to assist with promoting ethical conduct in epidemiologic practice and workforce development;
 prepares for emergency response and fosters collaborations, strong partnerships, and team-building to accomplish
 epidemiology program objectives.
- Coordinates state program planning efforts with respect to surveillance and other epidemiologic data and evaluation
 and develops and conducts training for local staff in the conduct of investigation and appropriate methods of
 controlling disease and preventing injuries.
- Provides technical leadership and guidance and coordinate work of Epidemiologist I.

Minimum Job Requirements:

A Master's degree in public health (MPH) or a master's of science degree in public health (MSPH) with a focus in epidemiology or analysis and assessment or other non-epidemiology graduate degree or certification (e.g., RN, RS) with specific epidemiology training (e.g., MPH degree, CDC Epidemic Intelligence Service or CSTE Applied Epidemiology Fellowship) or related field and two (2) years' experience in epidemiology and communicable diseases in a public health or related setting are required. May require KS/MO driver's license, depending on department or agency.

Johnson County Government requires reference/background screening for all positions. Specified criteria may vary by Department/Agency.

Preferred Job Requirements:

Doctorate degree in Epidemiology or Other non-epidemiology graduate degree or certification (e.g., MD/DO, DDS/DMD, DVM, PhD) with specific epidemiology training and one (1) year of experience in communicable disease and/or environmental health focus in a public health or related setting are preferred.
