### Notice of Second Public Meeting Nelson WWTP Complex Infiltration/Inflow Pilot Rehabilitation Project

Dear Property Owner:

Johnson County Wastewater (JCW) invites you to participate in the second public meeting to discuss sanitary sewer improvements in your neighborhood (the area in Shawnee bound approximately by 49<sup>th</sup> Terrace on the North, Johnson Drive on the South, Burton Lane on the East, and Long Street on the West). The public meeting will be held on **Thursday, February 17<sup>th</sup>, at 7:00 pm, at the Prairie Baptist Church, 7416 Roe Avenue** (see map on back).

If you cannot attend this meeting, a similar meeting will be held on Wednesday, February 16<sup>th</sup>, at 7:00 pm at the Shawnee Town Museum in the Town Hall Building, 11501 West 57<sup>th</sup> Street.

Representatives of JCW and their consultants will be present at these meetings to discuss different facets of the project. Residents will also have the opportunity to meet the project team, ask questions, and learn more about this project. This public meeting will focus on the planned construction activities and agreements needed from affected property owners.

A recording of the first public meeting which focused on the project purpose and approach is available on the project website (address below). A third public meeting is scheduled for later in 2011 to provide information on the construction schedule and construction-related impacts.

Improvement maps showing the work to be performed are provided on the project website (address below). If you received a construction access exhibit, work is scheduled for your property as part of this project and you should have recently received an exhibit that shows the work scheduled for your property. Depending on the type of work scheduled for your property, the exhibit mailing may have included one or two agreements that JCW is requesting you to voluntarily approve. This second public meeting will be an opportunity for you to return the signed agreement(s) or schedule an individual site visit at your property to discuss the work on your property with our project team.
