

**Sanitary Sewer Improvements Planned for Your Neighborhood**

**Notification of Field Activity  
Indian Creek Interceptor 2 Capacity Improvements Project**

Dear Property Owner:

Johnson County Wastewater (JCW) is working to increase capacity of the sanitary sewer system in your neighborhood. This will provide more dependable, cost-effective, and environmentally sound wastewater service to our customers. Our team of engineers, inspectors, and surveyors are continuing these efforts and designing the replacement of existing sanitary sewers in your neighborhood.

**How will my property be directly impacted?**

Field investigations and surveying activities may be needed on or near your property to gather topographical and surface feature data that will be used in the design. These investigations and activities will be performed by Burns & McDonnell and Kaw Valley Engineering, Inc. as contractors for JCW. Their personnel will carry a signed original of this letter as well as photo identification during these activities. These contractors will not require access inside your home or business.

**What is the schedule for this effort?**

Prior to construction, the existing features of the sewer system must be surveyed and the alignment identified. The information collected will then be used to prepare construction plans. Field investigation and surveying activities are scheduled to begin immediately and will last for several months.

**What do you need from me?**

In an effort to encourage property owner involvement, we are asking for your assistance and input as we proceed with the design phase of the project. Knowing your concerns early in the process will allow us to respond and, if possible, incorporate them into the design phase. The requested information will help us to move forward with this beneficial project.
