MINUTES OF THE MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF
JOHNSON COUNTY, KANSAS HELD ON THURSDAY, JULY 14, 1994

A regular meeting of the Board of County Commissioners of Johnson County, Kansas was held on Thursday, the 14th day of July, 1994 with the following members being present and participating, to wit:

WHEREUPON, there came on for consideration a request to include certain roads on the County Assistance Road System (C.A.R.S.) Program for possible participation of funding for improvement by Johnson County.

The Board of County Commissioners, upon a motion duly made, seconded, and carried, adopted the following Resolution, to wit:

RESOLUTION

Resolution No. 058-94

WHEREAS, Resolution No. 115-83 was adopted by the Board of County Commissioners of Johnson County, Kansas on the 17th day of November, 1983, and provides for the listing of those roads on the County Assistance Road System (C.A.R.S.) which are eligible for possible participation of funding for improvement by Johnson County; and

WHEREAS, the Board of County Commissioners of Johnson County, Kansas further amended that Resolution on the 14th day of November, 1985 (Resolution No. 114-85) and on the 1st day of February, 1990 (Resolution No. 05-90); and

WHEREAS, the Board of County Commissioners of Johnson County, Kansas is desirous of further amending said amended Resolution to provide for the addition of 55th Street from Roe Boulevard to Shawnee Mission Parkway; Corliss Road from 95th Street to 83rd Street; 95th Street from Edgerton Road to Cedar Creek Road; and Wyandotte Street from 83rd Street to the north City limits of DeSoto, Kansas, in order that said roads shall be

eligible for possible participation of funding by Johnson County under the C.A.R.S. Program.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Johnson County, Kansas, that:


1. The following shall be and hereby are declared to be additions to those roads which are eligible for possible participation of funding for improvement by Johnson County, Kansas:

55th Street	Roe Boulevard to Shawnee Mission Parkway;
Corliss Road	95th Street to 83rd Street
95th Street	Edgerton Road to Cedar Creek Road
Wyandotte Street	83rd Street to the north City limits of DeSoto, Kansas


2. That attached hereto and incorporated by reference as if fully set forth herein is a revised C.A.R.S. Program map showing those streets listed in Paragraph 1, together with all other roads previously deemed eligible for possible participation of funding for improvement by Johnson County, Kansas under the C.A.R.S. Program, and that said map may be used by the Board of County Commissioners of Johnson County, Kansas in determining which programs shall be selected for funding participation in any given year.


3. That this Resolution further amends Resolution No. 115-83 and shall become effective on the day and year first above mentioned.

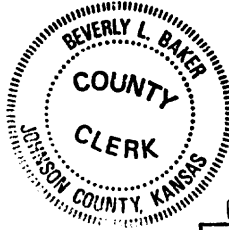
