

**RESOLUTION 017 -13**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS  
OF JOHNSON COUNTY, KANSAS, MODIFYING THE ELIGIBLE ROADS LIST FOR  
THE COUNTY ASSISTANCE ROAD SYSTEM (CARS) PROGRAM**

At a regular meeting of the Board of County Commissioners of Johnson County, Kansas, held on Thursday the 18 day of April, 2013, there came before Board for consideration the modification the current list of roads eligible for possible CARS Program funding assistance.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Johnson County, Kansas, that:

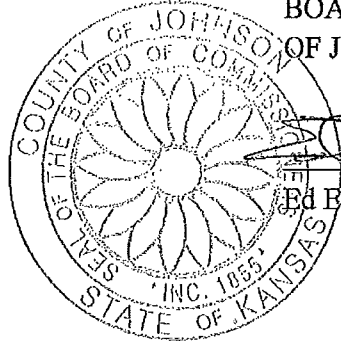
1. The following roads shall be and hereby are declared to be eligible for possible participation of funding through the CARS Program in addition to those already designated by the Board:






