

MINUTES OF MEETING OF THE BOARD OF COUNTY COMMISSIONERS
OF JOHNSON COUNTY, KANSAS, HELD ON THURSDAY, OCTOBER 7, 2004

WHEREUPON, there came on for consideration a request to modify certain roads on the County Assistance Road System (CARS) Program for possible participation of funding for improvement by Johnson County.

The Board of County Commissioners, upon a motion duly made, seconded, and carried, adopted the following Resolution, to wit:

RESOLUTION

Resolution No. 082-04

WHEREAS, Resolution No. 115-83 was adopted by the Board of County Commissioners of Johnson County, Kansas, on the 17th day of November, 1983, and provides for the listing of those roads on the County Assistance Road System (CARS) which are eligible for possible participation of funding for improvement by Johnson County; and

WHEREAS, the Board of County Commissioners of Johnson County, Kansas, further amended that Resolution on the 14th day of November, 1985 (Resolution No. 114-85); and on the 1st day of February, 1990 (Resolution No. 05-90); and on the 14th day of July, 1994 (Resolution No. 058-94); and

WHEREAS, the Board of County Commissioners of Johnson County, Kansas, is desirous of further amending said amended Resolution to provide for the addition and deletion of roads as noted in Paragraph 1 and Paragraph 2 of this Resolution in order that said roads shall be eligible for possible participation of funding by Johnson County under the CARS Program.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Johnson County, Kansas, that:

1. The following shall be and hereby are declared to be additions to those roads which are eligible for possible participation of funding for improvement by Johnson County, Kansas:

Barker Road, Johnson Drive to Shawnee Mission Parkway

Martindale Road, Shawnee Mission Parkway to 75th Street

Monticello Road, 47th Street to Johnson Drive

Clare Road, 43rd Street to 55th Street

Clare Road, 63rd Street to 79th Street

55th Street, Lackman Road to Quivira Drive

Lackman Road 55th Street to Johnson Drive



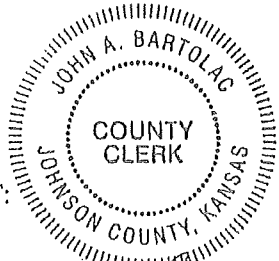


2. The following shall be and hereby are declared to be deleted from those roads which are eligible for possible participation of funding for improvement by Johnson County, Kansas:
 - Pflumm Road, 48th Street to 51st Street
 - Lackman Road, 51st Street to 55th Street
 - Woodland Road, Shawnee Mission Parkway to 75th Street
3. That attached hereto and incorporated by reference as if fully set forth herein is a revised CARS Program map showing those streets listed in Paragraph 1 and in Paragraph 2, together with all other roads previously deemed eligible for possible participation of funding for improvements by Johnson County, Kansas, under the CARS Program, and that said map may be used by the Board of County Commissioners of Johnson County, Kansas, in determining which programs shall be selected for funding participation in any given year.
4. That this Resolution further amends Resolution No. 115-83 and shall become effective on the day and year first above mentioned.


