Subject: 2021 Motor Vehicle Tax Estimates

Under the provisions of K.S.A. 79-5111 and for the purpose of preparing budgets, the Johnson County Treasurer shall estimate the amount of money the state, county and each taxing subdivision in the county will receive during the ensuing budget year from taxes levied under the provisions of K.S.A. 79-5101 et seq.

Attached you will find the tax estimates for the 2021 budget year including, motor vehicle tax, recreational vehicle tax, commercial motor vehicle fees, 16/20M tax, and excise (vehicle rental) tax. The estimates are provided as subtotals for each taxing subdivision. They are also provided at a more detailed level by tax fund per each taxing subdivision.

*Due to the impacts of the COVID-19 pandemic, the Johnson County Motor Vehicle offices were closed to the public from March 25 – May 10, 2020. The potential economic impact of COVID-19 continues to evolve rapidly and has disrupted the pattern of revenue recognition associated with motor vehicle registrations.
