This permit authorizes the permit holder to proceed with the work as described above and is conditioned upon strict compliance with all the provisions of Zoning and Subdivision Regulations and Resolution 069-08 as adopted by Johnson County. By signing this document, the undersigned agrees to comply with the approved Stormwater Quality Management Plan (SQMP) and/or special conditions, which may have been stipulated as conditions for permit issuance. This Stormwater Treatment Facility permit is subject to revocation upon any violation of the Zoning and Subdivision Regulations or Resolution 069-08.

The permit holder must notify the Director of Public Works or his designee (913-715-8300) before beginning construction of any Stormwater Treatment Facility. The Director must be notified of any changes to the approved SQMP construction schedule for the facility.

Upon completion of the Stormwater Treatment Facility, the Director will issue a Notice of Acceptance once the permit holder submits an As-Built Plan(s) showing, in detail, all construction changes from approved plans and specifications and a written Certification by a qualified Professional Engineer that the Stormwater Treatment Facility has been installed in accordance to the approved SQMP.

This permit shall become invalid if the authorized work is not commenced within 180 days after issuance of the permit, or if the authorized work is suspended or abandoned for a period of 180 days after the time of commencing work.

The Performance Surety will not be released until at least 90% of the land area served the by the Stormwater Treatment Facility has permanent stabilization in place and a Notice of Acceptance is issued for all Stormwater Treatment Facilities covered by this permit. If the Stormwater Treatment Facility (ies) is constructed prior to final stabilization of at least 90% of the land area served by the facility, and the most recent certification of the facility is more than 90 calendar days old, an updated certification is required to verify the facility is fully functional. The Maintenance surety will not be released until three (3) years after the date of completion of the issuance of the Notice of Approval. The Permit holder is responsible for keeping records associated with the permit and provide said records to the County when requested.
