**HOW TO PROVIDE PUBLIC COMMENTS**

- Public “live” comments for the March 10, 2021 meeting will be accepted only for those who have pre-registered. Registration closes at noon (12:00 pm) on Tuesday March 9, 2021.
- The Commission has established a limit of 10 speakers limited to 3 minutes of time and audio only. If more than 10 speakers attempt to register, the slots will be filled on a first come, first serve basis. If your registration is completed successfully, you will receive an email confirmation by 4:00 pm on Tuesday March 9, 2021 that includes instructions on speaking during the meeting. If an attempt to register is not successful due to the 10-speaker limit, your email response will include this information.
