- Supports Senior Engineering Technician, Project Managers, and Engineers in the management of projects and programs; applies engineering design standards and procedures in completion of routine project and program tasks; analyzes, researches, and interprets data during review of study and design projects and programs; develops and presents recommendations to project and program leads for assigned project and program tasks such as engineering plan review, field investigations, and construction management; documents and creates data in documents, files, and systems; completes quality control tasks for project and program submittals.
- Provides customer service through responding to inquiries from developers, contractors, consultants and the general public; provides information and assistance to stakeholders on standards, CIP project and program goals, and development activities.
