

## WASTEWATER BILLING INFORMATION

### RESIDENTIAL CUSTOMERS

#### What is Average Winter Water Usage (AWWU)?

The AWWU is your estimated wastewater flow based on water used during the previous year's winter months, on either three or four months of winter water usage, depending on how often the water company reads the water meter and your Johnson County Wastewater (JCW) billing cycle. If your water meter is read monthly, the AWWU is calculated using water consumed in January, February, and March. If your water meter is read every other month, your AWWU is based on water usage during a four-month period (approximately 120 days) that falls somewhere between November 1 and April 30. JCW follows industry standard by billing its residential customers based on the average of water used during the winter months. Water usage during the winter is the best method for reasonably estimating the volume of wastewater discharged to JCW's wastewater treatment facilities. Winter water usage is used to avoid charging for heavier summer uses that do not impact the wastewater treatment system like watering lawns and gardens, washing cars, or filling swimming pools.

A default AWWU may be assigned and billed to JCW customers when an accurate, measured, or calculated usage history is not available. The default bimonthly AWWU for single family residential customers is 11,400 gallons. Customers that are moving and staying in the JCW district or have recent documented AWWU from another purveyor may contact JCW to have their usage evaluated.

### EXPLANATION OF CHARGES

The service, usage, and strength (BOD and TSS) charges and other fees recover the costs associated with capital and operating expenditures.

\*Service charge is associated with billing and collections costs and recover a portion of the costs of treating storm water and groundwater which enter the sanitary sewer system.

\*\*Usage and strength charges recover the costs of capital and operating expenditures that pay for expansions, upgrades, major repairs of JCW's sanitary sewer system, and costs associated with the safe and efficient transportation and treatment of wastewater.

### SEWER MAINTENANCE

### PRORATION

Your invoice may be prorated based on days of service when applicable.

### INTEREST CHARGES AND PENALTIES

- Interest on delinquent accounts accrues daily at 9% per annum for balances less than \$10,000; 15% per annum for balances of \$10,000 and greater.
- JCW follows Johnson County Government's policy, which currently charges \$30 for returned checks and ACH debit returns.
- The property owner is liable for all past due amounts and all costs associated with collecting delinquent accounts. If the charges are not paid in full, a lien may be attached to the real property from which the fees are being collected and is subject to foreclosure and collection in the same manner that delinquent real estate taxes are handled under Kansas Law.
